SAMUEL M. GIANCANA, AKA, AR.

CG 6486-C\* ADVISED THAT GIANCANA RETURNED CHICAGO FRIDAY AM JANUARY 10 LAST AND PROCEEDED TO RESIDENCE IN OAK PARK WHERE HE REMAINED FOR REST OF THAT DAY. SOURCE STATED THAT AN INDIVIDUAL KNOWN ONLY AS LOUIE HAS BEEN MAKING REPEATED INQUIRY AT ARMORY LOUNGE AND DEMANDS THAT HE BE ALLOWED TO SEE GIANCANA. LOUIE CLAIMS THAT HE IS \$13,000 INTO UNNAMED HOODLUMS AND THAT ONLY GIANCANA CAN HELP HIM. NO INFORMATION GIVEN INFORMANT AS TO WHETHER MEETING ARRANGED FOR THIS INDIVIDUAL.

SOURCE FURTHER ADVISED THAT GIANCANA UNDOUBTEDLY OWNER OF ARMORY LOUNGE. DORIS FANELLI, IN DISCUSSION WITH CHUCK ENGLISH, STATED GIANCANA SHOULD CONSIDER SELLING RESTAURANT. FEELS THAT HE MIGHT MAKE SUCH A DECISION WHEN HE SEES HOW UNPROFITABLE OPERATIONS WERE FOR THE YEAR 1963. FANELLI FEELS RESTAURANT SHOULD BE OPERATED BY MAN AND WIFE COMBINATION OR THAT GIANCANA SHOULD LEAVE SOMEONE IN RESTAURANT TO WATCH OVER OPERATION. RECOMMENDATION HAS BEEN MADE THAT THE RESTAURANT PORTION OF THE LOUNGE BE CLOSED, LEAVING ONLY THE BAR OPEN. FROM CONVERSATION IT APPEARS THAT FINANCIAL SITUATION OF LOUNGE IS OF LITTLE IMPORT TO GIANCANA, BUT IS MAINTAINED MERELY FOR THE PRIVACY THAT IT PROVIDES FOR MEETINGS WITH HOODLUMS AND OTHER ASSOCIATES.

FURTHER CONVERSATION HELD ABOUT MARSHALL CAIFANO AND LEWIS BARBE, INSURANCE AGENT, MEETING AT LOUNGE. SOME DISCUSSION HELD RE INADVISABILITY OF USING LOUNGE FOR MEETINGS BUT ENGLISH ADVISED THAT IT MAKES NO DIFFERENCE "AS THE "G" KNOWS EVERYONE
