GUS ALEX, AKA. AR. DAILY SUMMARY.

CG SIX FOUR FOUR THREE DASH C ADVISED THAT REGARDING THE ORGANIZATIONAL BREAKDOWN OF THE QUOTE OUTFIT END QUOTE, IT WAS HIS OPINION THAT GUS ALEX IS UNQUESTIONABLY THE TOP MAN IN CHICAGO WITH MURRAY HUMPHREYS ACTING AS THE ELDER STATESMAN. INFORMANT SAID THAT SAM GIANCANA IS ALMOST ON AN EQUAL PAR WITH ALEX AND EXERTS OVERALL SUPERVISION OF THE WEST SIDE INTEREST WHILE ALEX IS MORE CONCERNED WITH THINGS IN THE LOOP AREA AND NEAR SOUTH CHICAGO. INFORMANT STATED THAT FRANK FERRARO IS NEXT IN LINE AND HAS DIRECT SUPERVISORY CONTROL OVER ALL CARD GAMES, GAMBLING INSTALLATIONS AND STRIP JOINTS IN THE LOOP AREA AND IS TIED DIRECTLY TO GUS ALEX. MAIL COVER ON MAILING ADDRESS OF ALEX DISCLOSED THAT HE RECEIVED MAIL IN EARLY JUNE ADDRESSED IN CARE OF HIS BROTHER GEORGE ALEX MARKED PERSONAL TO GUS FROM MISS LILLIAN MITCHELL, TWO TWO ONE WEST TWENTYFOURTH PLACE, CHICAGO. LILLIAN MITCHELL WAS CONTACTED AT HER RESIDENCE AND ADVISED THAT SHE WAS ACQUAINTED WITH GUS ALEX AND STATED THAT EVERYONE IN THE NEIGHBORHOOD KNOWS GUS ALEX. HOWEVER, WHEN QUESTIONED AS TO THE EXTENT OF HER ACQUAINTANCE SHE STATED THAT SHE DID NOT KNOW HIM OR ANYTHING ABOUT HIM EXCEPT THAT HE FORMERLY RESIDED IN THE NEIGHBORHOOD

MANY YEARS AGO. SHE STATED TTTA THAT SHE NOW WOULD PROBABLY NOT KNOW GUS ALEX IF SHE SAW HIM ON THE STREET. A PHOTOGRAPH OF ALEX WAS EXHIBITED TO HER AND SHE STATED THAT SHE DID NOT RECOGNIZE THIS INDIVIDUAL. WHEN ASKED SPECIFICALLY WHETHER SHE HAD EVER AT ANY TIME BEEN IN CONTACT WITH GUS ALEX SINCE HE MOVED FROM THE NEIGHBORHOOD SHE REPLIED THAT SHE HAD NO CONTACT WITH HIM WHATSOEVER SINCE THAT TIME. MITCHELL ANSWERED PRACTICALLY ALL QUESTIONS BY STATING THAT QUOTE I DON/T KNOW ANYTHING ABOUT GUS ALEX, I DON/T KNOW GUS THAT WELL END QUOTE. SHE STATED THAT SHE IS ACQUAINTED WITH ALEX/ SISTER STELLA SINCE SHE WENT THROUGH SCHOOL WITH HER, WHEN THEY LIVED IN THE NEIGHBORHOOD. THE NAME CARUSO WAS NOTED BY THE AGENTS ON THE MAIL BOX AT MISS MITCHELL/S RESIDENCE AND SHE WAS ASKED IN THE PRESENCE OF HER SISTER, MRS. PHILLIP CARUSO AND HER NEPHEW NICK CARUSO, WHETHER THEY WERE ACQUAINTED WITH OR RELATED TO FRANK QUOTE SKID END QUOTE CARUSO. MISS MITCHELL STATED THAT THEY WERE NOT RELATED TO FRANK CARUSO AND DID NOT KNOW HIM AND HER STATEMENT WAS CORROBORATED BY MRS. PHILLIP CARUSO AND HER SON, NICK. IT IS TO BE NOTED THAT FRANK QUOTE SKID END QUOTE CARUSO IS IN CHARGE OF A NUMBER OF HORSE BOOKS ON THE NEAR SOUTH SIDE OF CHICAGO ACCORDING TO INFORMATION PREVIOUSLY RECEIVED FROM CG SIX FOUR FOUR THREE DASH C. ALEX ARMED AND DANGEROUS WITH SUICIDAL TENDENCIES.
