Inasmuch as Phyllis McGuire has proved uncooperative in previous attempts at interview, and since PCI [redacted] has been able to furnish considerable personal information concerning Phyllis and others, it is suggested that [redacted] be contacted prior to interview with McGuire to ascertain the likelihood of her cooperativeness. (U)

OTHER 4

New York should attempt such a contact and advise the Bureau and Chicago of the results, following which Chicago should submit a further recommendation concerning the interview. (U)

NOTE: Chicago advises there appears to be a rift between Phyllis McGuire and Giancana and requests permission to interview McGuire to determine her degree of cooperativeness in furnishing information as to the activities of Giancana. (U)

Review of information available in the Chicago files indicates that the situation between SAM GIANCANA and PHYLLIS MC GUIRE is at a point where MC GUIRE might readily discuss her past relationship with GIANCANA with Bureau Agents. (U)

From information received from PCI [redacted] and PCI [redacted] it is evident that MC GUIRE has for the last several months, heeded the request of her sisters to discontinue seeing GIANCANA. (U)

A highly confidential source in the Chicago Division advised that during the week of 12/1/63, GIANCANA, during a telephonic conversation with PHYLLIS MC GUIRE, was highly berated and insulted by MC GUIRE on that occasion. This source has furnished other information recently to the effect that this phone call was not an isolated incident and in fact, MC GUIRE, has on several recent occasions, told off GIANCANA. (U)

Bureau permission is requested to have Agents of the New York Division, familiar with GIANCANA's activities, interview MC GUIRE to determine her degree of cooperativeness in learning of activities of which she is aware concerning GIANCANA. (U)
