Important contacts in the Mexican Government have expressed concern and curiosity about locally published accounts of Subject's prosecution reportedly pending in Laredo, Texas.

The Mexican Immigration Inspection Service has a file on the Subject, in part based on information furnished by this Office in the past, and has a current stop to prevent Subject's entry into Mexico as an undesirable.

Because of Subject's reported presence along the border, they were fearful that Subject may attempt to enter Mexico. In addition, they were curious as to why Subject was being prosecuted in Laredo for a crime committed in New Orleans.

As a matter of liaison and cooperation, it is felt that Mexico City should be in a position to answer Mexican inquiries concerning this matter.
