IT HAS BEEN PREVIOUSLY REPORTED THAT ORLANDO BOSCH AVILA AND EIGHT CO-DEFENDANTS WERE SENTENCED IN DECEMBER SIXTYEIGHT ON CHARGES RELATING TO SHIP BOMBINGS, CONSPIRACY AND EXTORTION. BOSCH WAS THE LEADER OF A CUBAN REVOLUTIONARY ORGANIZATION KNOWN AS THE MOVIMIENTO INSURRECCIONAL DE RECUPERACION REVOLUCIONARIA (MIRR) AND THE EIGHT CO-DEFENDANTS WERE MEMBERS OF THE SAME GROUP. THE EIGHT CO-DEFENDANTS WHO ARE NOW ON BOND, AND BOSCH, WHO IS SERVING A TEN YEAR PRISON TERM IN THE FEDERAL PENITENTIARY, ATLANTA, GEORGIA, HAVE APPEALED THEIR CONVICTIONS. THE DATE OF APPEAL HEARING HAS BEEN SET FOR JANUARY SIX, SEVENTY, IN THE FIFTH U.S. CIRCUIT COURT, JACKSONVILLE, FLORIDA. THE EIGHT CO-DEFENDANTS ARE ANDRES JORGE GONZALEZ GONZALEZ; JESUS DOMINGUEZ BENITEZ; JOSE DIAZ MOREJON; MARCO RODRIGUEZ RAMOS; BARBARO BALAN GARCIA; PAULINO GUTIERREZ VIDAL AND HIS SON JORGE GUTIERREZ ULLA; AND AIMEE MIRANDA CRUZ, A FEMALE.
