During the past thirty-day period ~~BERNIE GLICKMAN~~, a former fight manager and close associate of Chicago Top Hoodlums, was interviewed on several occasions. During these interviews ~~GLICKMAN~~ has furnished information concerning the forthcoming PATTERSON-LISTON heavyweight championship fight and has further furnished some information concerning activities of hoodlums in the Chicago area. Further interviews with ~~GLICKMAN~~ are contemplated at this time.

Interviews of several other hoodlums were attempted during the month; however, these interviews either met with no response from the hoodlums encountered or the agents were advised that the hoodlums would contact their attorneys and would thereafter recontact the FBI. In these instances the Chicago Division was contacted at a later date by attorneys representing these persons who stated that they did not feel it would be in the best interests of their clients to be interviewed.

This program is being followed closely and continued emphasis is being placed on interviews of persons with a knowledge of hoodlum activities in the Chicago Division.
