Re Mexico City letter to Bureau 10-16-70 (P) (U)

DATE: 10/18/85 CS MEX-287, contacted on various occasions, most recently 11-27-70, advised that he has heard nothing at all concerning the Subject, which indicates that Subject is still outside Mexico. (P) (U) (X)

Source will be in Acapulco over the Christmas holidays and anticipates that either Subject will be there, as has been his custom in past years or at least someone there will have heard from him. (P) (U) (X)

He noted that reportedly the singer EDDIE FISHER was residing in Subject's apartment in Mexico City recently in Subject's absence. THIS INFORMATION SHOULD BE MAINTAINED IN STRICT CONFIDENCE TO AVOID COMPROMISING SOURCE (P) (U) (X)

Mexico City surveillance informants MEX-42 and MEX-196 established discreet spot surveillance of Subject's apartment building, Amsterdam 82, Mexico City, during October and November 1970, and reported no activity of interest. They did not observe the Ford with Mexico City license KTE 78, believed to be Subject's car. (P) (U) (X)
