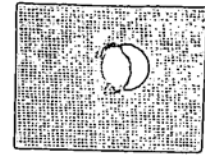
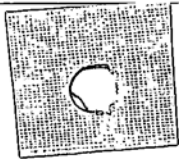

[REDACTED] PCI, (PROTECT), AVON PARK CORRECTIONAL INSTITUTION, FLORIDA, INTERVIEWED MARCH 27 LAST AND CLAIMED ORIGINALLY ENTERED FLORIDA NUMBERS RACKET THROUGH BEING INTRODUCED TO NORMA BRIDGES THROUGH VINCENT SQUILLANTI. SOURCE THEN WENT FROM NEW YORK TO ORLANDO, FLORIDA, AND NORMA BRIDGES SET HIM UP AS A BANKER. CLAIMED MET SUBJECT ON THREE OCCASIONS EACH TIME IN HAVANA, CUBA, IN 1958.
