On 5/29/62, [redacted] (protect), advised subject was at the Columbia Restuarant at 4:00 p.m. on 5/28/62 in the company of JAMES LONGO, SALVATORE LORENZO and FRANK ALONSO. Source stated subject was seen by source at 8:00 a.m., 5/29/62 at subject's residence.
