JOSE M. R. FUENTEVILLA GIL advised on 7/3/62, that until 6/30/62, he was Secretary of the Cafe D'Artist Cop., which corporation operates the Cafe D'Artist Night Club in Miami. FUENTEVILLA said he was a journalist in Cuba and because of this, he was requested by OTTO SIRGO and CAESAR ALOUYO, President and Vice President of the corporation, to become Secretary of the corporation, and handle the publicity for the night club. FUENTEVILLA said he had nothing to do with the actual operation of the Cafe D'Artist, and, therefore, knew little about the financial operations. He stated he knew the subject in Cuba as he handled publicity for the Sans Souci Hotel, in which the subject operated the casino.
