On 7/19/62, [redacted] PCI (protect), advised subject was alone at the Columbia Restaurant, 4:30 p.m., Sunday, 7/15/62 and had supper. Subject next appeared alone at Columbia Restaurant at 10:15 a.m., 7/19/62.

A white Chevrolet Impala, described above, observed at subject's residence in Tampa afternoon 7/19/62 and also car of FRANK TRAFFICANTE observed at subject's residence.

On 7/20/62, AUSA TOM HANLON advised USDJ JOSEPH LIEB set civil tax case concerning TRAFFICANTE's back taxes for 9/10/62 in a non-jury trial and he was not handling case, but someone from the Department of Justice, Washington, D.C., Tax Division, whose identity is unknown to him, would probably be handling the matter.
