Reference is made to San Juan letter and memorandum to the Bureau dated February 20, 1962.

(By letter dated April 16, 1962) in the case entitled "ARTURO R. ESPAILLAT," (Bufile 105-52901), the RCMP advised that the Canadian Department of Citizenship and Immigration had informed that its records did not reflect the entry into Canada of one FRANK CHAVEZ of Puerto Rico, and also that RCMP records contained no reference to this person. The RCMP advised that Canadian Immigration is making further inquiry through its Montreal office.
