VIII. MISCELLANEOUS

The West German Federal Criminal Police (BKA) advised that the Munich, Germany Police Department had contacted HELMUT MAIER on April 13, 1962, and attempted to solicit information from him in regard to GUS ALEX. MAIER is the ex-husband of SUZANNE FUEGER, paramour of ALEX. MAIER said that he was then employed by the export firm of Massrs. Linde and that his employers intended to send him to the United States in the future to represent them there. As a result, he declined to furnish any information in regard to GUS ALEX on the basis that he desired to protect himself from any possible future retaliations against him. The BKA informed that MAIER was born May 18, 1929, in Munich, Germany, and was residing at 200 Saebenerstrasse, C/O Haeussler, Munich 9, Germany, and that he was divorced on May 25, 1962, from DIETGARD ROSEMARIE MAIER, nee FEUGER. The BKA advised that DIETGARD MAIER was born December 3, 1938, at Seewalchen, Austria, and that her mother's name was ELROSE FUEGER, 12 Rosenstrasse, Munich, Germany.
