On February 11, 1963, the Bundeskriminalamt - (BKA - West German Federal Criminal Police) advised that according to a teletype message received from the Fuerstenfeldbruck Field Office of the Bavarian Criminal Police, the subject was not then at Riederau, West Germany, and that as far as could be determined, he was not there with SUSANNE FUEGER during the last several days prior to her departure on February 7, 1963 for the United States.

Re Bonn airtel 2/1/63 and Bureau cable 2/8/63.

On 2/11/63, the Bundeskriminalamt - (BKA - West German Federal Criminal Police) advised that according to information from the Munich Criminal Police, SUSANNE FEUGER left Munich, Germany, on 2/7/63, by Pan American Airways, en route to Frankfurt/Main, Germany, where she had passage booked on Pan American Flight #59, departing Frankfurt/Main, 12:35 PM, February 7, 1963, to arrive at Chicago, Illinois 11:20 PM, February 7, 1963.

The BKA also stated that it had been unable to develop any further information regarding the activities or present whereabouts of the subject himself.

The BKA has been informed that the subject reportedly returned to Chicago on the afternoon of February 4, 1963. The BKA was also advised that it might discontinue further active investigation regarding the subject but was asked to provide any information which its alerts to date may produce. If any such additional data is received it will, of course, be reported but this case is being RUC'd at this time.

On February 8, 1963, the U.S. Operations and Research Detachment informed that it had been unable to intercept any communications to FEUGER's mother noting that the location of her current address made only chance coverage through the Munich Post Office possible.
