CRIME CONDITIONS
MISSISSIPPI GULF COAST

On 6/14/62, NO 1178-C advised SA PERCY V. RICHARDSON of the Gulfport, Mississippi, RA, that during the early evening hours of 6/13/62 members of the Mississippi National Guard raided three gambling establishments on the Mississippi Gulf Coast between Gulfport and Biloxi. The informant identified these three places as the Gay Paree and the Key Club, located near Biloxi, and a club known as The Spot in Mississippi City. Liquor and gambling equipment valued at an estimated \$25,000 were seized and destroyed in these three raids.

Mr. TOM COOK, Reporter, The Daily Herald Newspaper, Gulfport, advised SA RICHARDSON on 6/14/62, that JACK NOLA SIDNEY DENNIS and JOHN ROMEO were arrested at the Key Club. BERNARD BLAIZE was arrested at the Gay Paree and J. L. PORTER and ROGER D'ANGELO were arrested at The Spot. The arrest warrants were issued by Mississippi Supreme Court Justice HENRY ROGERS, Jackson.
