FOR INFO OF BUREAU, BERNARD CAREY, COOK COUNTY STATES ATTORNEY, CHICAGO, CAUSED TO BE ISSUED SUBPOENAS FOR APPEARANCE HOODLUMS CHARLES ENGLISH AND DOMINIC "BUTCH" BLASI BEFORE COOK COUNTY GRAND JURY TO BE CONVENED IN THE NEAR FUTURE. COOK COUNTY STATES ATTORNEY HAS INVENTORIED ALL ITEMS CONTAINED IN DESK AND FILE CABINET AND HAS MADE COPIES OF THE ITEMS. THEY HAVE ALSO LISTENED TO GIANCANA TAPES SEIZED WITH NEGATIVE RESULTS PERTAINING TO POSSIBLE SOLUTION OF GIANCANA MURDER. FBI, CHICAGO IS ASSISTING COOK COUNTY STATES ATTORNEY IN ANALYSIS OF PAPERS AND ITEMS FOUND IN DESK AND FILE CABINET.

ON JUNE 27, 1975, CG 9561-CIE ADVISED THAT FROM A HIGHLY CONFIDENTIAL MEETING HELD EARLIER IN DAY WITH A HIGHLY PLACED HOODLUM LEADER, IT WAS LEARNED BY SOURCE THAT THERE WAS NO CONNECTION WITH THE YOUNG DISSIDENT ELEMENT OF ORGANIZED CRIME IN
