AS BUREAU AWARE, CARDI MURDERED IN GANGLAND FASHION AT JIM'S BEEF STAND, 1620 RIVER ROAD, MELROSE PARK, ILLINOIS, JULY 14, 1975. FOR INFO BUREAU, THIS BEEF STAND, MANAGED BY CARDI, IS PHYSICALLY LOCATED ON PROPERTY, ACCORDING TO RECORDS OF COOK COUNTY TREASURER'S OFFICE, BELONGING TO LAURENCE RIVER ROAD TRUST. AS BUREAU AWARE, THIS TRUST WAS ESTABLISHED WITH GIANCANA AND CHARLES ENGLISH AS PRINCIPAL BENEFICIARIES AND ALSO INCLUDED INCOME TO TRUST FROM LORMAR DISTRIBUTING COMPANY (RECORD BUSINESS OPERATED BY ENGLISH) AND WILCO AMUSEMENT COMPANY (VENDING MACHINE COMPANY OPERATED BY ENGLISH). PROFITS FROM THESE TWO COMPANIES WERE SHARED 50 PERCENT EACH BY ENGLISH AND GIANCANA.
