ANTIRACKETEERING

GUS ALEX, AKA, AR. DAILY SUMMARY. SERGEANT FRANK NASH, INTELLIGENCE UNIT, CHICAGO POLICE DEPARTMENT, ADVISED THAT INFORMATION HAS RECENTLY COME TO HIS ATTENTION THAT THE SUBJECT HAS TAKEN OVER CONTROL OF THE GAMBLING AND OTHER HOODLUM INTERESTS IN THE 45TH WARD OF CHICAGO. THIS WARD COVERS THE ~~TOWN~~ HALL AND SHEFFIELD AVENUE POLICE DISTRICTS AND WAS FORMERLY INDEPENDENTLY CONTROLLED BY ALDERMAN CHARLES WEBER, WHO RECENTLY DIED OF MONOXIDE POISONING. SERGEANT NASH STATED THAT ALEX WILL BE ASSISTED IN THE MANAGEMENT OF THIS WARD BY MARSHALL CAIFANO AND FELIX "MILWAUKEE PHIL" ALDERISIO. BOTH THESE HOODLUMS ARE CURRENTLY UNDER ACTIVE INVESTIGATION BY THE CHICAGO OFFICE. SERGEANT NASH OFFERED NO BASIS FOR THE ABOVE INFORMATION AND ITS RELIABILITY IS UNKNOWN. PCI [REDACTED] ADVISED THAT A PLATINUM BLONDE WITH A LONG PONY TAIL AND WHOM HE DESCRIBED AS YOUNG AND ATTRACTIVE CONTINUES TO VISIT THE SUBJECT'S APARTMENT ON A FAIRLY REGULAR BASIS. INFORMANT HAS BEEN UNABLE TO DETERMINE THE LENGTH OF HER VISITS WITH THE SUBJECT OR THE PURPOSE OF THE VISITS. HE IS ATTEMPTING TO DETERMINE HER IDENTITY OR THE MODE OF TRANSPORTATION SHE UTILIZES IN REACHING THE SUBJECT'S APARTMENT BUILDING. THE CHICAGO OFFICE WILL INTENSIFY EFFORTS TO IDENTIFY THIS INDIVIDUAL IN ORDER THAT SHE CAN BE INTERVIEWED REGARDING HER ASSOCIATION WITH THE SUBJECT.
