Re undated memorandum pertaining to ALEX forwarded by Bureau routing slip dated 6-5-61 requesting appropriate investigation at Interline, London, England, to determine itinerary of ALEX regarding his return to the United States. Also to determine if Interline has record of return flight for Mrs. ALEX during the week of May 9, 1961.

Chief Inspector JOHN PEARCE, New Scotland Yard, caused investigation to be conducted concerning ALEX and on 6-27-61 PEARCE furnished information as follows:

According to Chief Security Officer, British Overseas Airways Corporation, GUS ALEX on 5-9-61 was a first-class passenger on BOAC Flight BA 563 which flight departed from London for travel via Glasgow, Scotland and Montreal, Canada.

According to the Security Officer of Olympia Airways, GUS ALEX departed London Airport for Athens, Greece, on Olympia Airways Flight 410 on April 16, 1961.

PEARCE advised that no record could be located concerning ALEX's wife and that the foregoing is the only information available in London concerning GUS ALEX.

It is noted that re memorandum states ALEX is armed and dangerous and has suicidal tendencies.
