HE ADVISED THAT A POSSIBILITY EXISTS THAT STEIN MAY HAVE FALSIFIED THE CORPORATE RETURNS REGARDING WITHHOLDING TAXES FOR EMPLOYEES, ESPECIALLY IN REGARD TO LOUIS ARGER WHO MAY HAVE BEEN ON THE PAYROLL AS A FRONT AS A RESULT OF AN ALLEGED LOAN TO STEIN IN CONNECTION WITH THE SETTING UP AND OPERATION OF THE CORPORATION AND WAS MERELY BEING PAID A SALARY AS A RETURN FOR HIS INVESTMENT WITHOUT ACTUALLY PERFORMING ANY WORK OR SERVICES FOR THE CORPORATION. INFORMANT SAID THAT LADON IS ALWAYS ASKING FOR MORE MONEY, HOWEVER HIS REQUESTS ARE IGNORED BY VOGEL AND ALEX AS LADON HAS NO POWER AND IS MERELY AN ERRAND BOY FOR ALEX AND VOGEL. ALEX ARMED AND DANGEROUS WITH SUICIDAL TENDENCIES.
