GUS ALEX, AKA., AR, DAILY SUMMARY.

CG SIX FOUR FOUR THREE DASH C ADVISED THAT CORNELIUS PITT, CHICAGO ATTORNEY AND BUILDING CONTRACTOR, ADVISED HIM THAT LOUIS ARGER, AN ASSOCIATE OF THE SUBJECT, IS SELLING HIS HOME AT SIX ONE TWO EIGHT KEATING AVENUE, CHICAGO. PITT STATED THAT HE HOLDS A ~~QUOTE~~ "PHONY" ~~UNQUOTE~~ MORTGAGE IN CONNECTION WITH ARGER/S HOME. INFORMANT STATED THAT PITT DID NOT EXPLAIN WHAT HE MEANT BY A PHONY MORTGAGE. INFORMANT WAS ADVISED BY PITT THAT THE SUBJECT TOLD ARGER AND LOUIS TORNABENE WHO OPERATES THE SANTA FE HOTEL THAT HE IS GOING TO ~~QUOTE~~ KILL THEM ~~UNQUOTE~~ IF HE GETS IN ANY TROUBLE WITH THE GOVERNMENT. SUBJECT INDICATED TO PITT THAT HE HAD NEVER BEEN IN ANY SERIOUS TROUBLE WITH EITHER LOCAL OR GOVERNMENT AGENCIES FOR MANY YEARS AND IN FACT WAS NOT EVEN KNOWN AS A LEADER IN THE ~~QUOTE~~ OUTFIT ~~UNQUOTE~~ UNTIL HE BECAME ASSOCIATED.
