V. MISCELLANEOUS

Chief Inspector JOHN PEARCE, New Scotland Yard, London, England, caused an investigation to be conducted concerning ALEX on June 27, 1961, and furnished the following information:

According to Chief Security Officer, British Overseas Airways Corporation (BOAC), GUS ALEX, on May 9, 1961, was a first class passenger on BOAC Flight BA563, which flight departed from London for travel via Glasgow, Scotland and Montreal, Canada.

According to the Security Officer of Olympia Airways, GUS ALEX departed London Airport for Athens, Greece on Olympia Airways Flight 410 on April 16, 1961.

PEARCE advised that no record could be located concerning ALEX' wife, and that the above is the only information he could furnish concerning GUS ALEX.
