NOTE: Gus Alex, one of the 40 subjects of crash investigation looking toward early Federal prosecution, is at the present time in the northern Wisconsin, Minneapolis area on a fishing trip. Chicago has obtained access to the apartment adjoining Alex's apartment and has requested authority for survey to determine the feasibility of confidential coverage.

GUS ALEX, AKA, AR. DAILY SUMMARY. [REDACTED] PCI, ADVISED THAT HE NOTED ALEX AT HIS RESIDENCE APARTMENT ON AUGUST 20, LAST. PCI FURTHER ADVISED THAT HE HAD NOTED THAT THE CAR USUALLY DRIVEN BY NATHAN BUTCH LADON WAS PARKED IN ITS USUAL PLACE SINCE THE MORNING OF AUGUST 21, LAST. IT IS TO BE NOTED THAT ALEX AND LADON LEFT CHICAGO BY PLANE ON MORNING OF AUGUST 21, LAST, AS REPORTED YESTERDAY. [REDACTED] PCI, RESIDING IN APARTMENT 10D, 1150 NORTH LAKE SHORE DRIVE, FURNISHED A KEY TO CONTACTING AGENT TO HIS APARTMENT AND STATED THAT HIS APARTMENT COULD BE USED BY AGENTS OF THIS OFFICE ANY TIME IN HIS ABSENCE. AS PREVIOUSLY REPORTED, [REDACTED] APARTMENT ADJOINS THAT OF SUBJECT. BUREAU AUTHORITY IS REQUESTED TO CONDUCT A PRELIMINARY SURVEY IN AN ATTEMPT TO ESTABLISH CONFIDENTIAL COVERAGE OF SUBJECT'S APARTMENT. ARMED AND DANGEROUS WITH SUICIDAL TENDENCIES.
