Re my airtel November 12, 1964, advising subject's Chevelle appeared Tampa residence, Thursday, November 12.

On night of November 12, TP 97-C advised that subject and wife had dinner together alone at Columbia Restaurant.

Morning of November 13, subject's Chevelle located in parking lot adjacent to offices of attorney FRANK RAGANO. About noontime, JAMES C. LONGO appeared in his vehicle, and subsequently LONGO drove subject and FRANK RAGANO to Tampa-Sheraton motel where they had lunch with girls believed employed in FRANK RAGANO's office, and, subsequently, all three returned to RAGANO's office.

At 1:42 p.m., subject left FRANK RAGANO's office and drove alone to his residence, and fisur of same discontinued approximately 4:30. Approximately 5:30 to 6:30 subject observed at lounge of Tampa-Sheraton motel.
