Daily airtel. By separate letter the Identification Division was requested to ascertain if two latents in auto in which body of MARSHALL VENEZIALE found by Philadelphia Police Department during December 1954 are identical to fingerprints of CARL IPPALTO, FBI #773655; FRANK "Bumper" POLLASTRELLI, FBI #582826; and MICHAEL "Daylight" TRAMANTANA, FBI #44673; considering Ph 591-C\* identifies these as possible killers for BRUNO, and Ph 514-C, who is related to MARSHALL VENEZIALE, considers BRUNO as person who would know whocoused death of VENEZIALE.

Arranged with Philadelphia Police Department to obtain results of their inquiry regarding toll calls from various associates and locations BRUNO frequents. Reviewed records furnished Philadelphia Police Department prepared by ATTD and IRS, Philadelphia, during 1951 and 1958. Nothing of value noted of current interest.

Ph 591-C\* indicates BRUNO still in Florida. Ph 523-C said BRUNO's wife to join him in Florida during current week.

Recontacted confidential source, Bell Tell, Company, to show continued interest re BRUNO's residence so that Philadelphia Division will know if opportunity presents itself to establish confidential source there.
