GUS ALEX, AKA AR. DAILY SUMMARY

PCI CHARLES POSTL, OWNER, POSTL-S HEALTH CLUB, ADVISED THAT ALEX STILL CONTINUES TO FREQUENT THE CLUB ABOUT ONCE OR TWICE A WEEK. HE SAID THE LAST TIME ALEX WAS AT THE CLUB WAS ON JULY SIX LAST, AT WHICH TIME HE PERSONALLY GAVE ALEX SOME EXERCISES AFTER HIS STEAM BATH AND MASSAGE. HE SAID ALEX IS ONE OF HIS BEST CUSTOMERS, IS VERY QUIET AT THE CLUB AND NEVER CAUSES ANY DISTURBANCE.

POSTL SAID THAT HE WAS RECENTLY APPROACHED BY THE MANAGEMENT OF THE BUILDING AT ONE EIGHT EIGHT WEST RANDOLPH REGARDING THE BAD PUBLICITY THE BUILDING IS GETTING FROM THE LOCAL NEWSPAPERS BY PRINTING ARTICLES THAT ALEX AND MANY OF CHICAGO-S HOODLUMS FREQUENT THE HEALTH CLUB. HE SAID THE MANAGEMENT REQUESTED HIM TO ATTEMPT TO GET RID OF THESE HOODLUMS SO THAT THEY WOULD NOT BE FREQUENTING THE BUILDING. POSTL SAID HE TOLD THE MANAGEMENT THAT HE WOULD NOT DO THIS AND THAT HE WOULD RATHER HAVE THEM AS CUSTOMERS THAN ~~XXX~~ SOME OF
