GUS ALEX, AKA, AR. DAILY SUMMARY.

EDWARD GANS, RESERVATIONS MANAGER, CONRAD HILTON HOTEL, IMMEDIATE SUPERVISOR OF SUZANNE FUEGER AND WHO IS AN ESTABLISHED SOURCE, ADVISED THAT FUEGER HAD REQUESTED THAT SHE BE GIVEN THE FIRST TWO WEEKS OF OCTOBER OFF FOR HER VACATION. SHE DESIRED THESE SPECIFIC WEEKS, ACCORDING TO GANS, BECAUSE HER MOTHER WAS PLANNING ON VISITING THE UNITED STATES ABOUT THAT TIME. GANS STATED THAT HER MOTHER RESIDES IN MUNICH, GERMANY, AND DOES NOT SPEAK A WORD OF ENGLISH. GANS SAID SUZANNE TOLD HIM THAT SHE WOULD HAVE TO BE BY HER SIDE CONSTANTLY IN SHOWING HER AROUND SINCE SHE COULD NOT SPEAK ENGLISH.

GANS FURTHER ADVISED THAT ON THE WEEK END OF JUNE TWENTYTHREE DASH TWENTYFOUR LAST SUZANNE MENTIONED THAT SHE HAD BEEN WATER SKIING AND HAD INJURED HER RIGHT WRIST. ALEX AND SUZANNE ARE BELIEVED TO BE VISITING THE FARM OF ALEX- BROTHER AT CASSAPOLIS,, MICHIGAN, ON WEEK ENDS DURING
