GUS ALEX, AKA, AR, DAILY SUMMARY.

CG 6443 - C ADVISED THAT DURING MAY OF THIS YEAR THERE WAS A GRAND JURY PROBE IN NEW YORK CITY CONCERNING A \$25,000 GIFT TO THE LAST CAMPAIGN FUND DRIVE OF MAYOR ROBERT WAGNER, INFORMANT SAID THAT HE HAD ASCERTAINED THAT THERE HAD BEEN REPORTS THAT THIS GIFT WAS AN UNDER THE TABLE POLITICAL CONTRIBUTION BY A CHICAGO PARKING METER COMPANY, NAMELY THE DUNCAN PARKING METER COMPANY. THE GIFT WAS ALLEGED TO HAVE BEEN GIVEN TO A TOP CITY OFFICIAL AND THEN WENT INTO THE CAMPAIGN FUND. IT WAS LEARNED THAT THE NEW YORK DISTRICT ATTORNEY'S OFFICE HAD CALLED JEROME ROBINSON, PRESIDENT OF THE DUNCAN PARKING METER COMPANY, BEFORE THE GRAND JURY IN CONNECTION WITH THE PROBE AND THAT ROBINSON HAD FLATLY DENIED THAT THE \$25,000 HAD BEEN PAID.

IT IS TO BE NOTED THAT THE DUNCAN PARKING METER COMPANY SUPPLIES AND SERVICES ALL OF CHICAGO'S PARKING METERS. THIS COMPANY IS ALSO ATTEMPTING TO SECURE THE CONTRACT TO FURNISH AND MAINTAIN ALL OF NEW YORK CITY'S PARKING METERS.
