CG SIX FIVE FOUR THREE DASH C DASH TE ADVISED THAT HE HAD RECEIVED INFO THAT THERE HAS BEEN A CHANGE IN THE OWNERSHIP OF THE CLUB ROUGE, WHICH CLUB ALEX ALLEGED HE HAD A FINANCIAL INTEREST. ACCORDING TO INFORMANT THE CLUB WAS PREVIOUSLY OWNED BY JOE SMITH AND FRANK LA PORTE AND THAT POSSIBLY CHARLES ZERAVICH, MANAGER OF THE CLUB, REPRESENTED ALEX-S INTEREST IN THE CLUB.

INFORMANT STATED THAT NOW, LOUIS ARGER, HAS A SEVENTY FIVE PER CENT INTEREST IN THE CLUB ROUGE HAVING BOUGHT OUT FRANK LA PORTE-S INTEREST. ARGER IS ALLEGED TO HAVE CHARGE OF VICE AND STRIP JOINTS ON SOUTH STATE STREET FOR ALEX. JOE SMITH IS SUPPOSED TO HAVE THE REMAINING TWENTY-FIVE PER CENT INTEREST BUT WILL BE PAID ONLY TWO HUNDRED DOLLARS PER MONTH UNTIL THE COMPANY STARTS SHOWING A PROFIT. AT THAT TIME SMITH WILL RECEIVE TWENTY FIVE PER CENT OF THE PROFIT.

INFORMANT FURTHER ADVISED THAT JOE SMITH IS SUPPOSED TO STAY AWAY FROM THE CLUB ROUGE UNTIL QUOTE THE HEAT FROM THE POLICE DEPT. IS DOWN ENQUOTE. ACCORDING TO INFORMANT, SMITH ALSON HAS TO QUOTE TAKE ALL THE BEATS ENQUOTE IN THE OPERATION OF THE CLUB.

CHARLES ZERAVICH AND ACE PHILLIPS WILL CONTINUE TO WORK AT THE CLUB BUT ARE ALLEGED NOT TO HAVE ANY FINANCIAL INTEREST. ZERAVICH WILL CONTINUE MANAGING THE CLUB.
