CG T-40 advised that ALEX visits the club at least two or three times a week and that ALEX is given exercises by CHARLES POSTL, owner of Postl's Health Club. CG T-40 further advised that ALEX was instructed by his doctor to visit Postl's Health Club regularly and to take the exercises given to him by POSTL to quiet his nerves.

Agostino's Restaurant

CG T-40 advised that he had recently seen ALEX leave Agostino's Restaurant and enter a 1962 black Cadillac with Illinois registration 520925. This registration was determined to be listed to CHARLES ZERAVICH, jr., 2422 Clybourn Avenue. It was determined that CHARLES ZERAVICH in addition to residing at the above address is employed as manager of the Club Rouge where ALEX is alleged to have an interest.

CG T-1 advised that during the middle part of April, 1962 he observed GUS ALEX entering Celano's Custom Tailor Shop. CG T-1 stated that in the past ALEX has been a frequent visitor at Celano's and that he gets most of his clothes custom tailored at Celano's.

CG T-29 advised that he has received information that GUS ALEX and his associates still frequent Fritzel's Restaurant. In this regard CG T-29 advised that NATHAN LADON also spends a great deal of time at Fritzel's Restaurant and that he apparently waits there for messages from ALEX and EDDIE VOGEL, close associates of ALEX.
