CG 6502-C*, ADVISED THAT HE OVERHEARD ALEX COMMENTING TO HIS PARAMOUR, SUZANNE FUEGER, THAT HE WAS TIRED AND WOULD REST AT THE CLUB THAT DAY.

INFORMATION WAS RECEIVED FROM PCI CHARLES POSTL, OWNER, OF POSTL'S HEALTH CLUB, WHICH DISCLOSED THAT ON THE SAME DAY THAT ALEX MADE THE ABOVE REMARK TO SUZANNE, HE DID FREQUENT POSTL'S HEALTH CLUB. IT IS TO BE NOTED THAT ALEX HAS BEEN OVERHEARD ON MANY OCCASIONS IN THE PAST BY CG 6343-C* TO MENTION THE CLUB AND IT IS APPARENT NOW THAT ALEX WAS REFERRING TO POSTL'S HEALTH CLUB.

PCI POSTL FURTHER ADVISED THAT ALEX AND HIS CLOSE ASSOCIATE TOP HOODLUM, EDDIE VOGEL, VISITED THE HEALTH CLUB EVERY DAY LAST WEEK, APRIL 16 THROUGH APRIL 20, 1962. ALEX ARMED AND DANGEROUS WITH SUICIDAL TENDENCIES.
