CG SIX FOUR FOUR THREE DASH C RECENTLY ADVISED THAT LOUIS ARGER, STRIP JOINT OPERATOR FOR GUS ALEX, PURCHASED A NEW TWENTYSEVEN FOOT BOAT AT A COST OF SIXTEEN THOUSAND DOLLARS FOR HIS OWN PERSONAL USE. INFORMANT SAID THAT THE BOAT IS REGISTERED IN THE NAME OF THE NATIONAL MAINTENANCE CORPORATION AND THAT BEN STEIN, PRESIDENT, NATIONAL MAINTENANCE CORPORATION, HAS BEEN INSTRUCTED BY ARGER TO PREPARE THE BOAT FOR USE AND TO MAINTAIN THE BOAT AT PIER NINETEEN, BURNHAM HARBOR, CHICAGO.

INFORMANT STATED THAT HE BELIEVES THIS BOAT WILL BE USED BY BOTH ARGER AND ALEX DURING THE COMING SUMMER SEASON AND ALSO ADVISED THAT GUS ALEX SPECIFICALLY WANTED STEIN TO STAY OFF THE BOAT BECAUSE ALEX WANTED NO FURTHER ASSOCIATION BETWEEN HIMSELF AND STEIN DUE TO THE RECENT PUBLICITY LINKING THEM TOGETHER IN CONNECTION WITH THE
