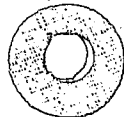

CG SIX FIVE FOUR THREE DASH PC ADVISED YESTERDAY THAT GUS ALEX AND FRANK LA PORTE ARE SILENT PARTNERS IN THE CLUB ROUGE, FIVE SIX WEST RANDOLPH STREET, CHICAGO.

INFORMANT SAID THAT JOE SMITH AND GENE QUOTE ACE UNQUOTE PHILLIPS ARE RUNNING THE CLUB AND ARE BELIEVED TO BE THE OWNERS OF RECORD. HE SAID SMITH IS ALEXS REPRESENTATIVE IN THE CLUB AND THAT PHILLIPS IS LA PORTES REPRESENTATIVE.

INFORMANT FURTHER ADVISED THAT SMITH AND PHILLIPS ARE AT ODDS WITH EACH OTHER AND A BREAK IN THEIR BUSINESS RELATIONSHIP IS ANTICIPATED IN THE FUTURE.
