On 3/28/62, according to Ft. Worth newspapers, Mrs. VIRGINIA GROODY, who is Secretary to Police Captain ED LEE in the Traffic Warrant Division was picked up on 3/28/62 by Ft. Worth police after a downtown department store (Monnigs) detective stopped Mrs. GROODY for shoplifting and found a \$25 dress in her purse. CONNIE ODOM, a Secretary, Ft. Worth PD, advised SA MYERS on 4/1/62 that Mrs. GROODY was formerly the Secretary to City Manager L. P. COOKINGHAM and had been shoplifting for over three years. Mrs. ODOM stated that RUSSELL YOUNG of the Property Division of the Ft. Worth PD told Mrs. ODOM that he had 150 dresses in the Property Room which Mrs. GROODY had shoplifted. Mrs. GROODY is presently out on a \$500 bond. (The information supplied by YEAGER above was furnished to JAMES DePRATO. IRS, by SA MYERS on 3/29/62, at which time DePRATO stated there was nothing much that could be done at this time with this information because of the year in which the payoff would have been obtained. DePRATO stated that this information may be valuable in 1964 or 1965 but that his squad was primarily concerned at this time with the years 1957 through 1960).
