MM 829-PC advised on 1/24/63 that he has known subject for a number of years and has had him as a client on several occasions. He mentioned that the subject had been in his office just a few weeks prior to the interview, but declined to discuss any specific matters relative to the subject inasmuch as he was a client. He made the comment that the subject has a very unusual personality, who appears to have considerable influence, but is the type of person that "one can never feel close to."

MM 829-PC may be characterized as a person who is in daily contact with the criminal element in the Miami area.
