WEEKLY SUMMARY

On 12/31/62, TP 50-C advised that on 12/22/62 FRANK DIECIDUE, JACK PARRINO, and an individual introduced as LOU met at the Dream Bar office for over two hours. It was overheard by FANO TRAFFICANTE telling NICK SCAGLIONE that this LOU was a close friend of SANTO TRAFFICANTE and that the purpose of the meeting was to resolve the question of a \$100,000 debt owed LOU CAGGIANO as a result of a gambling game at the Congress Inn, Tampa, some time before. CI had been told that as a result of the meeting PARRINO would not pay CAGGIANO the \$100,000 but would repay LOU CAGGIANO a sum between \$7,000 and \$14,000 as previously won by PARRINO from CAGGIANO.

On 1/2/63, TP 50-C identified a photo of LOUIS P. BRADY as being identical with the individual he had mentioned on 12/31/62 as LOU, who had met with FRANK DIECIDUE and JACK PARRINO.
