GERACI stated that subject had no money invested in Lehigh Acres for if he did, he, GERACI, would know about it. GERACI also furnished some details concerning some Cuban persons whom subject brought to his home in the past.

It would appear that subject's alledged trip to Brazil above may relate to the disappearance for subject from Miami during the period 10/19/62 to 11/6/62. Efforts are being made to gain further information in this regard.

On 12/21/62, TP 8-C advised he had received information that in the past several weeks, subject had been observed in an old model Nash automobile, faded blue in color, and bearing a Florida license, registration unknown.
