WEEKLY SUMMARY

Spot checks of residence of subject and known hangouts of subject when in Tampa, were checked during December 21-27, 1962 and nothing unusual noted.

On December 27, 1962, Detective Sergeant JACK DE LA LLANA, Intelligence Unit, Tampa PD, advised that a usually reliable source had advised him that subject had returned to Tampa immediately after Christmas. **A**

On 12/19/62, LOUIS P. GERACI, Cape Haze, Florida, a close personal friend of subject, advised that while he was convalescing from an operation in a Tampa hospital about a month ago, subject visited him. According to GERACI, subject had remarked that he had been in Brazil for about two or three weeks investing money in the coffee industry. GERACI placed this trip to Brazil possibly during the first three weeks of November, 1962. GERACI did not know any details concerning the coffee venture but stated that subject's investment was being made through "some jew" in Brazil. GERACI stated that he did not know the area in Brazil where the investment has been allegedly made but from his knowledge of

Brazil, he guessed it would be in the San Paulo area of Brazil.

GERACI stated that subject had no money invested in Lehigh Acres for if he did, he, GERACI, would know about it. GERACI also furnished some details concerning some Cuban persons whom subject brought to his home in the past.

It would appear that subject's alleged trip to Brazil above may relate to the disappearance for subject from Miami during the period 10/19/62 to 11/6/62. Efforts are being made to gain further information in this regard.

On 12/21/62, TP 8-C advised he had received information that in the past several weeks, subject had been observed in an old model Nash automobile, faded blue in color, and bearing a Florida license, registration unknown.
