WEEKLY AIRTEL SUMMARY

Remyairtel, 12/14/62, and Miami teletype, 12/20/62.

Spot checks of subject's home reflected no unusual activity during the past week although two cars observed that will be checked out more completely.

On 12/20/62, PCI [redacted] advised subject TRAFFICANTE was in the Columbia Restaurant at Tampa about 5:20 PM talking to JOSEPH RAYMOND DIEZ, aka., Tampa file 168-74, Bufile 168-86. Informant further advised there was to be a party that night in the Columbia either given by SANTO TRAFFICANTE or for SANTO TRAFFICANTE.

As requested in referenced airtel, Miami was telephonically advised of above information furnished by PCI [redacted]. Miami advised there were two Departmental Attorneys and three IRS men from Philadelphia in Miami and interested in [redacted] Miami requested the head of IRS Intelligence Unit in Tampa be advised of circumstances and they would advise Departmental Attorneys and IRS Agents in Miami to contact him. Consequently, JOE B. HILL, Agent in Charge of the IRS Intelligence Unit at Tampa, was telephonically furnished information in referenced teletype and fact that TRAFFICANTE was in town and at Columbia Restaurant and that representatives from his department and in Miami would be in contact with them.
