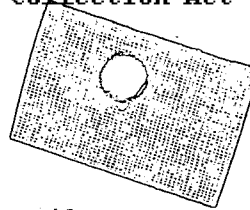
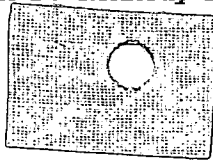

CI heard JAMES PALMISANO, FBI # 601072, has a "piece" of this restaurant. CI also heard subject has a financial interest in the restaurant.

On 10/19/62, JOHN L. BUELL (Protect Identity at his request), Doorman at Blair House Apartments, Bay Harbor Island, Fla., telephonically contacted SA C. GRAHAM HURST and advised he learned LOUIS BRADY, SANTO TRAFFICANTE, JR., and another white male believed to be DANIEL A. LAMAR, were at Blair House Apartments during early morning hours of 10/19/62 in 1961 Lincoln, 1962 Fla. license 1WW11175, issued to DANIEL A. LAMAR, 91 Tulip, Floral Park, Long Island, N. Y.
