MM 834-C\* advised on 9/7/62, that subject and wife are still residing at 523 Northeast 71st Street, Miami.

MM 753-PC, who is characterized as an associate of racket figures in the Miami area, was interviewed on 8/16/62, by SAs DON W. WALTERS and EDWIN B. JONES, and he advised that the subject's daugthter, MARY JO, who is a school teacher in Tampa, and her husband recently visited the subject in Miami.

He also advised that TONY RANDAZZO is an old friend of the subject's and the subject assisted RANDAZZO financially when RANDAZZO first arrived in the Miami area and was attempting to establish a restaurant. He further added that he knew the wives of RANDAZZO and the subject were very close friends and that they visit socially quite often.

MM 753-PC was asked specifically as to what kind of business the subject was in and what he does in the Miami area, to which the source replied, "I wouldn't dare ask him."
