GENERAL INVESTIGATIVE DIVISION

This concerns the suspected bombing of Cubana Airlines DC-8 near Barbados, West Indies, October 6, 1976.

Attached from Miami Office advises of information received from Dade County Public Safety Department (DCPSD), Miami, Florida, that information had been received from an unknown source in Caracas, Venezuela, to the effect that 15 persons, including a well-known anti-Castro Cuban exile leader (presumed to be Orlando Bosch Avila) had been arrested in Venezuela in connection with bombing of Cubana Airlines. SA Joe Leo, Legat, Caracas, confirmed this information by telephone, advising official announcement of arrest and identities of those arrested have not been made by the Venezuelan Government, however, SA Leo has been notified of arrests and of Government's (Venezuela's) apprehension concerning reprisals against Venezuelan officials and property in the United States.]c

SA JOE LEO, LEGAT CARACAS, CONFIRMED ABOVE INFORMATION BY TELEPHONE, ADVISING OFFICIAL ANNOUNCEMENT OF ARREST AND IDENTITIES OF THOSE ARRESTED HAVE NOT BEEN MADE BY VENEZUELAN GOVERNMENT, [HOWEVER, SA LEO HAS BEEN NOTIFIED OF ARREST AND OF GOVERNMENT'S APPREHENSION CONCERNING REPRISALS AGAINST VENEZUELAN OFFICIALS AND PROPERTY IN THE UNITED STATES, ]
