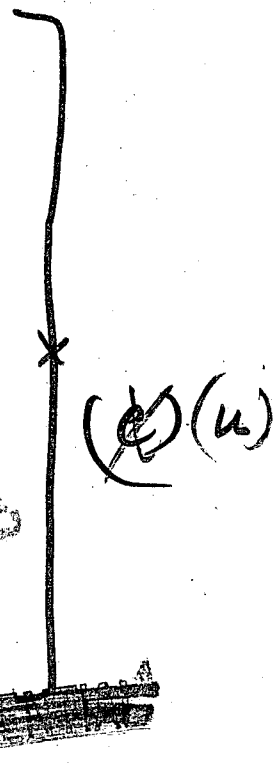

~~AS FURTHER INFORMATION ON THIS MATTER, ON OCTOBER 6, 1976, SOURCE ADVISED THAT RAFAEL PEREZ DORESTE TOLD SOURCE THAT SECUNDINO CARPERA TELEPHONED PEREZ DORESTE ON OCTOBER 6, 1976, SAYING HE WANTED TO TALK TO THE BOYS IN MIAMI AND THAT CARPERA WOULD BE FLYING TO MIAMI IN THE VERY NEAR FUTURE.
