Referenced Bureau letter furnished copy of Department letter dated 11/16/65 requesting investigation of matter originally set out in referenced Miami LHM of 9/22/65. Based on information developed to date it appears likely that the information furnished by MM 974-S which was set out in that LHM, prepared under the MRR caption in view of the previous association of SANTIAGO ALVAREZ with the MRR, is related to the attack which took place on 11/14/65. There is no indication to date of involvement by the MRR in this attack. Both DIAZ and IZA declined to implicate ALVAREZ claiming that he is "semi-retired" from revolutionary activity. Efforts are being made to arrange interviews with both ALVAREZ and his son and results will be submitted promptly thereafter. (Xm)

MM T-1 is MM 974-S. The informant is attempting to ascertain additional details which will assist in fully identifying the unknown participants. (Xm)

Information set forth in the enclosed LHM from DIAZ and IZA has been included in FD-302s being maintained in Miami file 105-8280. (Xm)
