Enclosed are 9 copies of letterhead memorandum captioned as above, suitable for dissemination.

This memorandum has been classified SECRET because it contains a Cuban's critical analysis of CIA activities in Central America. It is suggested that limited dissemination be made to CIA only in view of the nature of the information. *(S)(u)*

MM T-1 is AGAPITO ROJAS CARDENAS, 435 S. W. 10th Avenue, Apartment 104, Miami, Florida. ROJAS has Immigration & Naturalization Service (INS) Number A 12 895 216. He was born on August 18, 1921, at San Luis, Pinar del Rio, Cuba. He last entered the United States March 22, 1965, at Miami, Florida, with papers given him by the Movimiento de Recuperacion Revolucionaria (MRR), an anti-CASTRO organization [in which CIA has an operational interest] *(S)(u)*

ROJAS first furnished some of the information set forth in the enclosed letterhead memorandum to MM 776-S, who in turn had ROJAS contact SA PETER J. NERO. MM 776-S stated that he has known ROJAS for some time, and ROJAS is a sincere and reliable individual. It is noted that ROJAS informed SA NERO that he formerly was employed in the tobacco fields of an American concern in Cuba, and that he always has had a high regard for the United States and its citizens. It is also noted that ROJAS has had very little formal education. *(S)(u)*
