MM 92-515

MM 665-C, on 12/5/62, advised he learned KRISTINE KISTLER, girl friend of VINCENT ALO (Miami File 92-109) won golf honors among the women at the Normandy Isle Golf Club, Miami Beach, Fla.

This source also advised that HARRY BROOKS (Miami File 92-657) returned from his summer trip to Europe and then went to Puerto Rico. He related he heard that BROOKS recently returned from San Juan, Puerto Rico to Miami, and is trying to interest individuals in buying 200 acres of land at \$6,000 an acre, claiming the land is owned by a friend of his.

MM 509-C advised that CHARLES LEVINE, aka "Shikey" LEVINE, a gambler and at times a small time bookmaker, has been fronting for MICHAEL COPPOLA (Miami File 92-101) in efforts to secure a hangout for COPPOLA and his group in the Sival Motel, 236 - 21st Street, Miami, Beach. He was told some remodeling has to take place, before quarters are available. This source, on 12/17/62, advised plans toward establishing this club has been held up temporarily because of various raids pulled by IRS the past week. In the meantime, COPPOLA hangs out at JOSEPH MASSEI's office (Miami File 92-122) and at George's Newstand, 23rd and Liberty, Miami Beach, operated by HARRISON LEVINSON, JR.

This source also advised that on 12/13/62, a number of law enforcement officials and politicians were invited to a preopening of Ciro's Lounge, North Miami Beach. He stated the principal operators are FRANK DEL PRETE, JAMES PALMAISANO (Miami File 92-403) and STEFANO RANDAZZO (Miami File 92-503). He also remarked that this group is having difficulty securing a beer and wine license as the Florida Beverage Bureau is objecting to DEL PRETE's name on the license because of DEL PRETE's criminal record. According to his information the group served wine but did not charge for same. He understood an opening "for the racket element" was scheduled for Saturday night, 12/15/62.
