Down payment for this home was alleged to be provided by L. MONES, Miami Beach gambler, CHARLES TOURINE aka Charles White, Miami top hood, and FAT THE BUTCH (NICHOLAS DI COSTANZO). The informant was not able to state how this information could be verified or substantiated.
