MM 743-C reported that he heard SERGET KIRPATOVSKY (MM 165-13) formerly a wire service operator and currently reputed to be in the securities business, was ordered out of the Philippine Islands the past summer by the Immigration Bureau. He was told that when in the Philippines, KIRPATOVSKY attempted to secure control of the Benquet Consolidated Co., an American mining company, but failed.

MM 698-C advised that LEE BROOKS, son of HARRY BROOKS (MM 92-657), who married MARGOTT JIMENEZ, daughter of MARCOS PEREZ JIMENEZ, is now residing with the JIMENEZ family in their palatial residence at Miami Beach and is head of the household, as MARCOS PEREZ JIMENEZ is in jail.
