contemplated gambling casino would be the big problem as they feel the customers would be stopped from leaving the shores of the United States.

MM 744-C advised that the Surfside Six Floating Homes became a Florida Corporation in 1960, and the officers are LAWRENCE VITA, President, RALPH WEIDLER, Vice President and LOUIS RONES, Treasurer. RONES is an accountant and has no financial interest in the business. WEIDLER for the past eleven years has been doing subcontracting work under his own name at Levittown, Pennsylvania, and prior to that did sub-contracting work for Levitt & Sons in New York City for eleven years and before that he was construction superintendent for Levitt & Sons. This source related the Surfside Six Floating Homes, Inc., maintains an average medium four to low five figure balance at the bank, has a secured loan of five figures and pays its obligations from prompt to sixty days slow. He also related VITA is allegedly single and about 47 years old.

It should be noted the proposed "Atlantis Isle" gambling casino is allegedly a multi-million dollar venture, and the operation of the Surfside Six Floating Homes indicates a large amount of the money would have to come from other sources.

MM 509-C-TE also reported that he received information that JOHN TRONOLONE (MM 92-455) is no longer bookmaking, that he turned his customers over to EDDIE GOLD, but secures a certain per cent of the amount his old customers lose. According to his information, TRONOLONE is now shylocking and playing gards at the Patio Bridge Club, Miami Beach.
