He said WEBB has been taking TV sets from White's Auto and Western Auto Stores regularly. WEBB is driving a 1959 Chevrolet with 1962 Texas license NW 5785, which is registered to his father, B. H. WEBB, at the above address.

Above information was furnished to Captain WALTER FANNIN, Burglary and Theft, Dallas Police Department on 1/8/63, who advised the police department has been plagued with numerous TV burglaries as described by informant. Information also furnished to Sheriff BILL DECKER, Dallas Sheriff's Office.
